ORDER

Whereas, the Manufacturer's Cooperative Industrial Estate Ltd. is registered vide registration No. 1841 with this department under the provisions of DCS Act & Rules and bye-laws of the Society;

And whereas the Registrar Co-operative Societies has now granted approval of the appointment of Sh. B. S. Vashist, DANICS (Retd.), Flat No. C-369, Divya Jyoti Apartment, Sec-19, Rohini, Delhi-110085 as Administrator-Cum-Returning Officer under Section 35(5) of DCS Act, 2003.

And whereas it is submitted that General Secretary of the society has request to appoint an election officer in the society to conduct the entire election proceedings with the help of the society on dated 9.10.2019. As the tenure of the present Management Committee of the society has been expired on 23.12.2018.

As per section 35(5) of DCS Act, 2003:-

Thereafter the committee shall arrange election of the new committee before of its term and in case the committee fails to do so, the committee shall cease to hold office on expire of its term and the affairs of the cooperative society shall be managed by an administrator appointed by the Registrar who shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment.

Now, therefore, I, Amitabh Joshi, Assistant Registrar (T&C) hereby convey the approval of the Competent Authority to appoint Sh. B. S. Vashist, DANICS (Retd.), Flat No. C-369, Divya Jyoti Apartment, Sec-19, Rohini, Delhi-110085 as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the Society who shall conduct election of the Managing Committee of the Society look into the matter within stipulated period 90 days from the date he assumes the charge as Administrator-Cum-Returning Officer.
