**ORDER U/S 35 (5) OF DCS ACT, 2003**

Whereas, Defence Ministry Employees Co-operative Group Housing Society Ltd. is registered vide registration No. 101-GH with this department under the provisions of DCS Act & Rules and Bye-laws of the Society;

And whereas, a complaint dated 12.06.2019 (Copy enclosed) received in this office from 19 members regarding election of the Managing Committee of the society wherein they have stated that Sh. Manoj Kaushik (GSTO) was appointed as Returning Officer under section 35 (1) of DCS Act, 2003 to conduct the election vide order dated 05.03.2019. The Returning Officer has issued the Agenda Notice to conduct the election on 22.03.2019. It was also informed that 09 candidates submitted their nomination forms, only four were illegible and the nomination of 05 candidates were rejected by the Returning Officer. In the absence of non conduct of election by the Returning Officer to form a new Managing Committee, the existing management committee is functioning only to conduct the day to day function of the complex and they have further requested to ensure the smooth and normal functioning of the society;

Now, I, Amitabh Joshi, Assistant Registrar (Sec-II/GH) hereby convey the approval of the Competent Authority to appoint **Mr. Jagat Bhushan Kapil, A.O. (DFS)** as Administrator-Cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Defence Ministry Employees Co-operative Group Housing Society Ltd. (Regn. No.101-GH) with immediate effect at the remuneration of **₹.10,000/-** (Rupees Ten Thousand Only) per month and Traveling Allowance applicable as per circular dated 29.09.2016 (copy enclosed) to be paid from the fund of the Society and to hold the election of the Managing Committee of the Society within stipulated period 90 days from the date of appointment as Administrator-Cum-Returning Officer.
