



ORDER

1. Whereas the **Delhi Municipal Press Co-operative Group Housing Society Ltd.** is registered with registration No.1303-GH with the Department under the provision of DCS/Act/Bye-Laws of the Society and
2. Whereas the Delhi Co-operative Societies Act, 2003 has come into force with effect from 01/04/2005 vide Notification dated 24.03.2006. As per the provision of Section 35(1) of DCS Act, 2003 the entire process of the election of the managing committee of the Co-operative Societies shall be conducted by Returning Officers to be appointed by the Government who shall not be below the rank of Gazetted Officer, and
3. Whereas in exercise of the powers vested in him under section 35(1) of the DCS Act, 2003 the Competent Authority is pleased to appoint **Mr. Navneet Singh, (APPCO UNIT'S OFFICER)** as Returning Officer for holding the election of the full Managing Committee of the aforesaid Society as per DCS Act, 2003 DCS Rule, 2007 and Registered Bye-Laws of the said Society. The expenses of the election will be met out from the funds of the Society.
4. The Managing Committee/ Administrator of the Society shall incur the expenditure on conduct of the election as per the requirement of the Returning Officer. No funds shall be placed at the disposal of the Returning Officer.
5. The Society/Administrator is further directed to furnish the relevant documents to the Returning Officer within Seven (07) days from the date of receipt of this order.
6. The Society/Administrator shall paid ₹. 6,000/- (Rupees Six Thousands Only) as honorarium to the Returning Officer for conducting the election of the Managing Committee of the Society after completion of the election process.
7. The election shall be conducted on Saturday, Sunday and Gazetted Holidays only except National Holidays.
8. The guidelines for conducting the election are as per Schedule-II of DCS Rules, 2007.


