Office Cooperative Cooperative Thrift & Credit Society Ltd. Society Ltd. registered address Room No. 24, 2nd Floor, Old Civil Supplies Building, Tis Hazari, Delhi-110054 with direction to verify the status of the society and submit the status report at the earliest. Sh. Shivom kumar had visited the society office on 11.01.2018 at 11:00 Am at above mention address, where he found that the Room No. 24, 2nd Floor was closed and not in used last three years as also informed by the official Sh. Tarun, Baillif of SDM Civil Line posted in Room No. 26 who also informed that there is no such society running In the office compound.

Further, Sh. Shivom Kumar visited the SDM (Head Quarter), 5, Samnath Marg, Delhi-110054 and met to Mr. Sunil Kumar, UDC in Room No. 204, 2nd Floor, B-Wing and did not get any information about this matter.

Whereas, this office was written letters to Divisional Commissioner dated 26.06.2018, 04.09.2018, Special Secretary (Services) 04.09.2018 and Sh. Rehmat Elahi (Secretary) D. C. DCA, 8/36, First Floor, Tilak Nagar, New Delhi-110018 as Liquidator u/s 99 of DCS Act 2003, with the direction to complete the process of liquidation within 03 months of the issue of this order. The Liquidator shall be paid Rs. 10,000/- as remuneration for liquidation from the funds of the Society.
