ORDER

WHEREAS Shri Ashok Kumar Tyagi, Care Taker while posted in OHB-II, Kingsway Camp was placed under suspension vide order No. F.6(53)/DWCD/Admn/2013/21596 dated 11.11.2013 while contemplating disciplinary proceedings against him.

AND WHEREAS the suspension of Shri Ashok Kumar Tyagi, Care Taker was revoked vide order No.6(53)/DWCD/Admn/2013/11585-590 dated 04.7.2014.


AND WHEREAS a Show Cause Notice was issued to Sh. Ashok Kumar Tyagi, Caretaker vide No.F.3(248)/DSW/Vig./2016/730 dated 04/11/2016 seeking his explanation with regard to the act of omission and commission in the matter of an incident held in the night of 15.10.2013 at around 10-10.30 pm when two inmates, viz. Chirag and Rohit had escaped from the said Institution after breaking open at least 3 gates, 1 grill and 2 locks.

AND WHEREAS after considering the reply of Shri Ashok Kumar Tyagi, Care Taker and examining all the facts available, the Disciplinary Authority observed that no documentary proofs are available on record to prove the culpability of Shri Ashok Kumar Tyagi as Superintendent, OHB-II has informed that all documents, registers and other government properties were damaged and ruined in the incident of arson & vandalism took place on 17.12.2013 by the inmates of the Home and he was issued a warning to remain careful in future vide No.F.3(248)/DSW/Vig./2016/2015-2018 dated 10/04/2019.

AND WHEREAS in view of the above facts, the period of suspension w.e.f. 11.11.2013 to 04.7.2014 needs to be decided, as to whether same should be treated as spent on duty or not.

AND WHEREAS in terms of FR54-B(3) since the matter against Shri Ashok Kumar, Tyagi has been closed without initiating any formal Disciplinary Proceedings and by issue of a warning to him, the period of suspension needs to be regularized as spent on duty for all purposes.

Now, therefore, the Competent Authority i.e. Secretary, Social Welfare, after considering all these facts, has ordered that the period of suspension w.e.f. 11.11.2013 to 04.7.2014 in respect of Shri Ashok Kumar Tyagi, Care Taker is treated as spent on duty for all purposes and accordingly, the said directions are conveyed herewith.
