I am directed to convey the administrative approval and expenditure sanction of the Competent Authority, Department of Social Welfare, GNCT Delhi of Rs.15, 91, 63,652/- (Rupees Fifteen Crore Ninety One Lakh Sixty Three thousand Six Hundred Fifty Two only) for construction of School cum Home for Mentally Challenged Children at Usmanpur, Delhi . Out of which Rs. 50, 00,000/- (Rupees Fifty Lakh only) is hereby released as 1<sup>st</sup> Installment in the Financial Year 2019-20 to start the construction of above said work whereas remaining amount would be released after getting the sufficient budget in R.E. 2019-20 and B.E. 2020-21.

**This sanction is being issued with the condition that:**

1. Project shall be completed as per approved scope of work within 14 months at the sanctioned cost of Rs.15, 91, 63,652/-. No cost escalation will be considered in future.
2. The tender shall be invited as per approved cost, considered on the recommendation of the department.
3. Compliance of pre-sanction/post-sanction guidelines/requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period.
4. Completion of all the codal formalities, under GFR, 2017.

5. All guidelines issued by Central Vigilance Commission (CVC) for construction/maintenance/repair of building must be followed.
6. GRIHA rating system consists of 34 criteria categorized under various sections such as Conservation and Efficient Utilization of Resources, Building Operation and Maintenance, and Innovation points shall be taken under consideration besides Provision of Rain Water Harvesting and Accessible parameters while construction of this project.
7. PWD will be responsible for the quality of work.
8. PWD is also required to submit quarterly progress report during construction and utilization/completion certificate after completion of the said works under reference to the Department of Social Welfare.
