**ORDER**

Whereas authorisation for two days refresher training course for drivers badge, conductor license /badge, for drivers of commercial vehicles ( including HMV) was granted to M/s Simons Motor Driving Training & Research Society, A-118, Avantika Enclave, Sector-2, Rohini, Delhi vide order dated 23-03-2012 for the following --

1	Refresher Training Course for Drivers Badge (all P.S.V)	Two days
2	Refresher Training Course for Conductors Licence Badge(all PSV)	Two days
3	Refresher Training Course for drivers of commercial vehicles (including HMV)	

Whereas the said authorisation of the above institutes was suspended vide order dated 07-04-2016 on the recommendation of committee constituted to inquire into the complaints in respect of authorisation given to various institutes and with the approval of competent authority.

Whereas the above said Society went to Hon'ble High Court against these orders in WP(C ) 3246/2016 and CM No-13846/2016. The Hon'ble High Court vide its order dated 26-04-16 directed to issue fresh Show Cause notices to the petitioner within one week, afford an opportunity of hearing to the petitioner and thereafter pass a fresh speaking period within a period of eight weeks.

Whereas the Society was issued a fresh Show Cause notice vide dated 20-05-2016 by M.L.O., (NW Z-II), Rohini. The Society has filed a reply on the show cause notice on 27-05-2016. No final speaking order have been passed in the case.

Whereas it was found appropriate to give one final opportunity to the society to submit that they fulfilled all the criteria and guidelines for refresher training course for driver and conductor PSV badges including HMV and Rule 24 to 31 of CMVR Act, 1989 which provide for the detailed infrastructure and syllabus for imparting training by MDTS for different categories of license, at the time the authorisation was issued to them and one final opportunity to appear before the Licensing Authority was given to them for 24-09-2019.

Whereas the Secretary of the said Society appeared on 24-09-2019 and filed a written submission and sought the copy of Mongia Committee Report which was provided to him on the said date and his request for providing time to submit documentary proof in this regard was allowed and next date of hearing was given for 07-10-2019.

Whereas none appeared on 07-10-2019 nor any communication received from the Society. It seems that the Society has nothing more to add nor they have any documentary




proof to negate the deficiencies pointed out in the Mongia Committee Report. Thus the finding of the committee that –

- 1) The licence granted in accordance with the provisions of Rule 24 & 25 for the establishment of institute for imparting instructions in Driving in respect of all types of Motor Vehicles to M/s. Simons motor driving training and research society may have flaws on the following grounds ;
  - i) The licence under the provisions of Rule 24 & 25 does not seem to applied by the institute.
  - ii) No proof regarding payment of requisite application fee paid by the institute is available on file.
- 2) The authorization issued to M/s. Simons motor driving training and research society for imparting training for two days refresher course for PSV badge for drivers & conductors is also seems to be in violation of the guidelines issued in this regard.
- 3) From the Form 11 issued on 01/03/2012 and the application of Sh. Sanjay Kumar as proprietor of M/s. Simons Motor driving Training School, it can be inferred that the firm was still continuing as Simon Motor driving Training School. Moreover the documents of the property are in the name of Smt. Mukesh devi W/o Sh. Sanjay Kumar and not in the name of Society or the proprietor, as stated by Sh. Sanjay Kumar. There is no documentary proof with regard to any lease / rent agreement or transfer of title of the property in the name of the society.

Still holds and remain unanswered by the society.

In view of above findings of the committee, the permission /authorization granted to M/s Simons Motor Driving Training & Research Society for issuance of two days refresher training course for driver and conductors badge including HMV is hereby withdrawn with immediate effect.

M/s. Simons Motor Driving Training & Research Society, if aggrieved with the above decision may file an appeal under the provisions of Rule 27 to 29 of CMVR 1989 if so desired.


