ORDER

1. The Ministry of Road Transport & Highways, Govt. of India vide G.S.R. 1162(E) dated 04.12.2018 and S.O. 6052(E) dated 06.12.2018 notified that vehicle manufacturer shall comply with the procedure in regard to High Security Registration Plate (HSRP) including the third registration mark, for a new vehicle to be sold on or after 1<sup>st</sup> April, 2019. In the said notification dated 06.12.2018, it was also notified that:-

*(i) For the affixation of HSRP on existing vehicles, the high security registration plate including the third registration mark may be supplied and affixed by the dealers of the vehicle manufacturers after placing the mark of registration thereon.*

*(ii) The manufacturers or suppliers of high security registration plates, if so authorised by the state concerned, may also supply the high security registration plate including the third registration mark on old vehicles after placing the registration mark.*

2. The Environment Pollution (Prevention & Control) Authority (EPCA) and the Hon'ble Supreme Court are also monitoring the progress of affixation of colour stickers in WPC No.13029/1985 titled M.C. Mehta v/s UOI & Others.

3. In the meeting held on 24.09.2019 at 1500 hrs under the chairmanship of Jt. Secretary (MVL) regarding integration of High Security Registration Plates with VAHAN database by vehicle manufacturers, it was *interalia* decided that 'For the issue of providing and fixation of HSRP on existing vehicles, State Government has to take a decision that either the HSRP plates be supplied through authorised OEMs dealers or select HSRP manufacturers'.

4. Vide GSR 1162 dated 04.12.2018, the following has been prescribed by MoRTH:-

*"Provided that the High Security Registration Platte including the third registration mark, wherever required shall be supplied by the vehicle manufacturers alongwith the vehicles manufactured on or after the 1<sup>st</sup> April, 2019 to their dealers and the dealers shall place a mark of registration on such plates and affix them on the vehicle."*

5. In accordance with the notification of MoRTH, GOI vide GSR 1162 dated 04.12.2018 and order dated 06.12.2018, it has been decided for affixation of HSRP on existing vehicles, the high security registration plate including the third registration mark may be supplied and affixed by the dealers of the vehicle manufacturers after placing the mark of registration thereon. The dealer shall obtain the HSRP and hologram based colour sticker only through authorised source of concerned OEMs in NCT of Delhi and the affixation of HSRP shall be made by using the data through the VAHAN software.

6. The dealers of OEMs shall be required to strictly comply with the notification dated 04.12.2018 and specifications prescribed in S.O.6052 dated 06.12.2018 regarding HSRP and third registration mark / colour stickers.

7. In case of old vehicles already affixed with HSRP, only the hologram based colour stickers will be affixed by the vehicle dealers as per arrangements already made by OEMs.

8. HSRP alongwith hologram based colour stickers shall not be affixed through any other source at all except through the dealers authorised by OEMs.

9. This issues with the prior approval of the competent authority.
