In continuation of this office order No. F. 9(37)/DWCD/Admn./CWO/DSW/2012/2836-61 dated 26.10.18, contractual engagement of following 09 incumbents to the post of Welfare Officers is hereby extended w.e.f. 05-04-2019 to 31-03-2020 or till regular incumbents join the posts whichever is earlier, on existing terms and conditions and on monthly consolidated remuneration as worked out on the basis of formula as prescribed vide O.M. dated 20.01.2017 of Finance Department, i.e minimum of Pay or the first level of the pay matrix (Level-6) applicable to the respective post + DA, so as to ensure that the remuneration payable to the persons engaged on contract basis is on uniform rate. This rate shall remain same till the expiry of the contract period as per detail below:-
