### Terms & Conditions

- 1. A person to be selected as Chairperson of the Committee shall have a minimum of seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.
- 2. The Chairperson of the Committee shall be above the age of 35 years of age.
- 3. No person shall be appointed for a period of more than three years as a member of the Committee
- 4. A Chairperson of a Committee shall be eligible for appointment of maximum two terms, which shall not be continuous (3 years Gap).
- 5. The Chairperson may resign at any time by giving one month's notice in writing to the State Government.
- 6. No Chairperson'shall be selected if he/she;
  - (i) be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Committee as per the Act and rules;
  - (ii) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest.
  - (iii) hold any office in any political party during his/her tenure, or
  - (iv) be insolvent.
  - (v) Has been involved in any immoral act or in an act of child abuse or employment of child labour;
- (vi) The Chairperson will be paid <u>honorarium of Rs. 3500/- per sitting as per present norms</u>.
- (vii) The duties of CWC call for <u>full time sitting from 10.00 AM to 5.00 PM for 5/6 days a week</u>.
- (viii) During the verification of documents, if the candidate does not meet eligibility criteria as per Juvenile Justice (Care & Protection of Children) Act 2015 and Model Rules 2016 thereunder, he/she may not be allowed to interact with State Level Selection Committee.
