F.2/9/2019-20/Fin(B)/1667-1682,1701-1706,1794-1807,1856-1867,1961-65,2097-2102 dated 13/12/2019(Supplementary Grants-II) issued by Finance (Budget) Department in respect of this department under Demand No. 8 - Major Head-'2225', '2235', '2236' & '4235', I am directed to intimate the Budget allocation status at present for the Financial Year 2019-20 as per Annexure attached. Further, all the PIO/DD/HOO/DDOs shall ensure that:

- 1. At the outset, no expenditure will be incurred in excess of allocated budget estimates.
- 2. Expenditure must be incurred for the purpose for which funds have been provided.
- 3. First priority shall be given for making payment of essential items e.g. Electricity, Water and Telephone etc., accordingly necessary provision shall be kept out of allocated budget.
- Adequate mechanism shall be effectively applied for prevention, detection of errors & irregularities in financial proceedings so as to safeguard of public money:
- 5. The expenditure shall be incurred as per the delegation of powers allocated to the HOOs.
- 6. All the rules/instructions for principles of expenditure and payment from state exchequer shall be strictly adhered to including economy instructions issued by GOI and GNCTD from time to time.

- 7. Non utilization of the available provisions/funds by any office will be viewed seriously, as this would have deprived of some other needy unit from utilising the same.
- 8. Submit detailed monthly expenditure statement to the S.O.(Plg.), Planning Branch, DWCD by 3rd of the following month positively and PAO reconcile statement of the same by 10th of following months.
- 9. The expenditure out of Centrally Sponsored Scheme shall be strictly incurred as per guidelines issued by Govt. of India from time to time.
- 10. Onus of any Excess or Savings will be Upon the PIO/DD/HOO concerned.

Budget Allocation in respect of the remaining heads of accounts shall remain the same as already communicated on 03/04/2019.
