Sub:- Appointment to the post of Lecturer (Civil Engineering & Construction Technology) under the Directorate of Training & Technical Education, Govt. of NCT of Delhi.

Consequent upon selection to the post of Lecturer (Civil Engineering & Construction Technology) by the Union Public Service Commission and after having been declared medically fit for entry into Govt. Service by the Civil Surgeon/ Medical Officer, Sanjay Gandhi Memorial Hospital, Delhi, the Hon'ble Lt. Governor, Delhi is pleased to appoint Mr. Nitish Kumar to the post of Lecturer (Civil Engineering & Construction Technology) purely on provisional basis in the pay scale of Rs. 15600-39100/- plus AGP Rs. 5400/-. Dearness and other allowances as admissible under the rules in force from time to time, on the terms and conditions laid down in the offer of appointment and accepted by him.

His appointment is temporary and on probation basis for one year which may be extended at the discretion of the Competent Authority. His appointment is also subject to verification of qualification documents/ Certificates including caste and physically handicap certificate by the concerned district authorities.


His appointment is also subject to verification of character and antecedents from the concerned authorities.

Mr. Nitish Kumar is hereby directed to report for duty at the DTTE (HQ) latest by 06/08/2020 failing which his appointment shall stand cancel without any further communication.

NOTE:- It is also informed that UPSC vide letter No. F.1/65(15)/2018-R.V/SPC-I dated 06.09.2019 has conveyed the decision of Hon'ble High Court issued vide interim order dt. 27.05.2019 in W.P. (C) 5919/2019 titled Mohd. Fasih Ahmed and Ors. vs UPSC and Ors that "*The selection in question pursuant to advertisement challenged in the present petition shall be subject to the outcome of the present petition. Renotify on 24.09.2019.*"

Therefore, in compliance of Hon'ble High Court interim order dated 27.05.2019, Your appointment to the post of Lecturer (Civil Engineering & Construction Technology) shall be subject to the outcome of the present petition, as directed by Hon'ble High Court, Delhi in W.P.(C) 5919/2019.
