Sub:- Appointment to the post of Lecturer (Electronics & Communication Engineering) under the Directorate of Training & Technical Education, Govt. of NCT of Delhi.

Consequent upon selection to the post of Lecturer (Electronics & Communication Engineering) by the Union Public Service Commission and after having been declared medically fit for entry into Govt. Service by the Civil Surgeon/ Medical Officer, Sanjay Gandhi Memorial Hospital, Delhi, the Hon'ble Lt. Governor, Delhi is pleased to appoint Mr. Kavinder Tiwari to the post of Lecturer (Electronics & Communication Engineering) purely on provisional basis in the pay scale of Rs. 15600-39100/- plus AGP Rs. 5400.
