Sub:- Appointment to the post of Lecturer (Electrical Engineering) under the Directorate of Training & Technical Education, Govt. of NCT of Delhi.

Consequent upon selection to the post of Lecturer (Electrical Engineering) by the Union Public Service Commission and after having been declared medically fit for entry into Govt. Service by the Civil Surgeon/ Medical Officer, Sanjay Gandhi Memorial Hospital, Delhi, the Hon'ble Lt. Governor, Delhi is pleased to appoint Ms. Monika Agarwal to the post of Lecturer (Electrical Engineering) purely on provisional basis in the pay scale of Rs. 15600-39100/- plus AGP Rs. 5400/-. Dearness and other allowances as admissible under the rules in force from time to time, on the terms and conditions laid down in the offer of appointment and accepted by him.

Her appointment is temporary and on probation basis for one year which may be extended at the discretion of the Competent Authority. Her appointment is also subject to verification of qualification documents/ Certificates including caste and physically handicap certificate by the concerned district authorities.

Her appointment is also subject to verification of character and antecedents from the concerned authorities.

Ms. Monika Agarwal is hereby directed to report for duty at the DTTE (HQ) latest by 14/8/2020 failing which his appointment shall stand cancel without any further communication.

Therefore, in compliance of Hon'ble High Court interim order dated 27.05.2019, Your appointment to the post of Lecturer (Electrical Engineering) shall be subject to the outcome of the present petition, as directed by Hon'ble High Court, Delhi in W.P.(C) 5919/2019
