**ORDER**

**Reference: Regarding Examination for the Final Semester/Year students for Even Semester Diploma Level Examination-2020.**

Whereas the Hon'ble Supreme Court in its judgement of Special Leave petition 10042 of 2020 has clearly stated that **"The State and Universtiy cannot promote the students in the final year /terminal semester without holding final year/ terminal examination."**

In view of above, notification No.F.5(89)/91-Aca/BTE/Vol-III/Part File-3/792 dated 11/08/2020 stands withdrawn with immediate effect.

In supersession of all Previous orders/notifications/circulars other than circular No.F.5(89)/91-Aca/BTE/Vol-III/Part File-3/890-897 dated 08/09/2020 issued by the Board of Technical Education, Delhi on the subject cited above, it has now been decided that:-

- 1) Even Semester Diploma Level Examinations-2020 for **Final Semester/Year i.e., VI/VIII semester for semester pattern students and final year exam for annual pattern students (Pharmacy & Trade diploma course)** will be held at the home polytechnics/institutes (Govt./Govt. Aided/Private) of the student w.e.f. 21/09/2020 and be completed on or before 03/10/2020.
- 2) Both BTE Theory and Practical examinations for final semester/year will be conducted in the home institutes of the candidates and therefore concerned subject teachers of concerned institute will prepare question papers on their own as per BTE syllabus at institute level for theory examinations. No Remuneration will be paid for Paper Setting/Moderation/Translation of question paper.
- 3) Evaluation of theory answer sheets will also be done at institute level by the concerned subject teacher and only final award lists will be forwarded by the institute to the BTE strictly within one week after completion of examination.
- 4) Regular Students of II/IV semester or II/IV/VI semester in case of P/T course/ Tool & Die course will be promoted on the basis of internal assessment (50% credit) and their previous year's performance in end-semester BTE Examination (50% credit). Students in 1<sup>st</sup> year of Pharmacy course will be promoted on the basis of marks of internal assessment/practical.
- 5) In addition to this order, Circular No.F.5(89)/91-Aca/BTE/Vol-III/Part File-3/890-897 dated 08/09/2020 regarding examination for the Back/Compartment students for Even Semester Diploma Level Examination-2020 shall also be followed.
- 6) For conducting examinations, Principals of all the institutes/polytechnics must ensure that social distancing shall be maintained in each and every examination hall/room and all the staff of the institute & students appearing in the examination must wear face mask. Hand sanitizer must also be available in each and every examination hall/room in the institutes and other guidelines issued by authorities of Govt. of India and Govt. of NCT of Delhi regarding Covid-19 shall be followed.
