ORDER

Consequent upon grant of Third Financial Up-gradation under Modified Assured Career Progression (MACP) Scheme from Pay Level 3 (Rs.21700-69100) of Pay Matrix to Pay Level 4 (Rs.25500-81100) of Pay Matrix w.e.f. 29/08/2019 vide Order No. F.9(2)/DOA/Estt./2014/dcaudit/1341-1346 dated 24/02/2020 and on submission of option under F.R.-22 for fixation of pay after granting annual increment w.e.f. 01.07.2020, the pay of **Sh.
