**FIRE SAFETY CERTIFICATE**

Certified that the **Hotel Wall City** situated at 287, Fatehpuri, Delhi-06, comprised of ground + 02 upper floors, ground floor – (commercial use and other's property), 1<sup>st</sup> floor- (reception + 14 guest rooms), 2<sup>nd</sup> floor - (15 guest rooms), Terrace floor -( 02 store room + 02 staff rooms + dining hall). The guest house was granted FSC by this department vide letter no. F6/DFS/MS/GH/2017/949 dated 04.07.2017 for 29 guest rooms. The premises was re-inspected by the officer concerned of this department on **07.02.2020** in presence of manager and found that the building has deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010 and the premises is fit for occupancy of class **Residential, sub division A-1, having 29 guest rooms up to third floor only**, with effect from 12/02/2020 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under rule 40 and subject to conditions under rule 38 of Delhi Fire service Rules, 2010 printed below.

Condition for the validity of fire safety certificate

2. All the fire safety arrangements provided therein shall be maintained in good working conditions at all times.
3. Any loss of life or property due to non functional fire safety measures shall be at the responsibility of the management.
4. The trained fire fighting staff should be available round the clock.
5. Any deviation w.r.t. construction etc. shall be verified by the concerned building sanctioning authority.
6. This fire safety certificate may not be treated in any case for regularization of unauthorized construction, if any.
7. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in)
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".

The fire protection system was randomly checked and tested and was found functional at the time of inspection. Pantry on terrace has been removed and has been converted into dining area for occupants of the guest house, 02 store and 02 staff rooms were found on terrace along with lift room.

In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter No. F6/DFS/MS/GH/2017/949 dated 04.07.2017 is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010.


