In view of the deemed compliance of minimum standards of fire prevention and fire safety measures as required under the Rules, the FSC issued vide letter No. F6/DFS/MS/GH/2016/NDZ/1340 dated 02.09.2016 is recommended to be renewed under Rule 35 of the Delhi Fire Service Rules 2010.
