Consequent upon the recommendations of Departmental Screening Committee held on 10.08.2020 and further approval of CEO, DJB dated 10.08.2020, following Superintendent Engineers (E&M) are hereby promoted to the post of Chief Engineer (E&M) on Ad-hoc basis with immediate effect, initially for a period of one year in the first instance, in the pay band- 4 of Rs. 37400 - 67000 with Grade Pay of Rs. 10,000/- (pre-revised under 6th CPC) now converted into Pay Level-14 (1,44,200 – 2,18,200) of the Pay Matrix under 7th CPC, plus usual allowances as admissible under the rules, as a stop gap arrangement on functional requirement, or till such time the post is filled in on regular basis through UPSC or till retirement on attaining the age of superannuation or till further orders, whichever is earlier.

Further, the above arrangement is subject to the following term & conditions :

1. The ad-hoc promotion will not confer any right on the officers to claim for regular promotion to the post or next higher grade or any other service benefit.
2. That the period of service rendered on Ad-hoc basis will not count as officiating in the higher grade for any purpose including seniority in that grade.
3. The Competent Authority can terminate the above interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
