Consequent upon the recommendations of the Departmental Promotion Committee and further approval of the Competent Authority, Sh. Kanta Prasad Yadav, Assistant Accounts Officers (Emp.Code-20005893) S/o Sh.R. P. Yadav is hereby promoted to the post of Accounts Officer on Ad-hoc basis in the Pay Matrix Level-9 of Rs.53100-167800 (Pre-Revised Pay Scale in PB-2 of Rs.9300-34800 with grade pay of Rs.5400) plus usual allowances as admissible under the rules with immediate effect initially for a period of one year in the first instance or till such time the posts are filled in on regular basis, whichever is earlier :-

However, the ad-hoc promotion is subject to the following conditions:-

- 1. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or any other service benefit.
- 2. The period of service rendered on ad-hoc will not count on officiating in higher grade for any purpose.
- 3. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
- 4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- 5. In reference to DOP&T OM DATED.15/6/2018 bearing no.36012/11/2016-Estt.(Res.I)(Pt-II), it is subject to final outcome of the SLP No.30621/2011 pending before Hon'ble Supreme Court of India and other court cases, if any.
- 6. The aforesaid Ad-hoc promotion to the post of Accounts Officer is subject to final outcome of investigation by CBI in the matter of JAO Part-II examination held in 2013.

The posting order of above mentioned officers shall follow soon.
