- 4). That on conclusion of the disciplinary case/criminal prosecution which results in dropping of allegation(s) against any senior person, then the Junior most officiating person will be reverted.
- 5). Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- 6). In reference to DOP&T O.M. dated 15.06.2018 bearing No.36012/11/2016/Estt.(Res-I){Pt-II} dated 15.6.2018, it is subject to final outcome of SLP(C) No.30621/2011 pending before Hon'ble Supreme Court of India and other cases, if any.
- 7). The above official will required to under go one week training successfully in terms of approved RR by the CEO, DJB on 19.10.2015.
