AND WHEREAS, the inquiry Officer in her inquiry findings has held both charges stand proved.

AND WHEREAS, after accepting the in-house inquiry report and going through all the relevant facts along with representation/request of individual dated 28.08.2020, the Competent Authority by taking the lenient view has now pleased to order for his fresh reengagement.

NOW, THEREFORE, Shri Ajay Kumar S/o Lt. Sh. Ramesh Dabas, Beldar on M/Roll c/o EE(E&M)-HP-I is, hereby **re-engaged afresh as Beldar on Muster Roll** on Compassionate Ground, subject to following terms & conditions;

- 1. His past muster roll service rendered by him on muster roll is forfeited and not count for any regularisation/pecuniary and seniority of his past services as M/Roll.
- 2. The intervening period from 05.06.19 to till joining will be treated on the principle of "No Work- No Pay".
- 3. DDO will **obtain the assurance from the candidate before taking him on duty** that No Case/FIR/Any Judiciary inquiry against pending him.
- 4. That his engagement will further subject to fresh verification of his character and past antecedents from police since April 2019 to till now, which will be got verified from the DDO concern within 01 month of his re-engagement. Further the caste certificate wherein the name may be rectify as per educational certificate which has been got verified by the then DDO.

- 5. Medical fitness will be obtained again through MOI, DJB. If individual is not found fit for the given post, his service will be liable to be terminated without any further notice.
- 6. He will maintain the dependent/family members of the deceased employee.
- 7. That his engagement is further subject to the satisfactory work and conduct report during the period of service.
- 8. He will be governed by the rules & regulations, instruction and guidelines applicable to the other Muster Roll workers of Delhi Jal Board.
- 9. If he remains absent continuously from his duty for more than 30 days without any written permission/intimation allowed by the DDO, then his service will be considered as disengaged automatically. He will be not taken back on the duty until and unless specific approval from Competent Authority i.e. Member (Administration) DJB is received.
- 10. In case of failure on any of the above counts, M/Roll engagement shall liable to be terminated without notice.

Further, individual is posted in the office of EE(E&M)H.P.-I with immediate effect and directed to report in the office of EE(E&M)H.P.-I for further duties, under intimation to this office.
