Code-20009983, Garden Chaudhary on regular basis is hereby promoted to the post of Section Officer (Hort.) on Ad-hoc basis in PB-2 of Rs. 9300-34800 with Grade Pay of Rs. 4200/- (Pre-revised) (Level-6 of pay matrix as per 7th CPC) plus other usual allowances as admissible under the rules with immediate effect initially for a period of 01 (One) year or till further orders whichever is earlier subject to the following terms & conditions-:

- The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or next higher grade/regular promotion or any other service benefit.
- 2. That the period of service rendered on ad-hoc basis in the grade concerned would not count for any purpose including seniority.
- 3. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
- 4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- 5. The ad-hoc promotion is also subject to final outcome of court case pending before the Hon'ble CAT vide M.A. No. 1629/2019 in O.A. No. 3427/2018.
