O R D E R

1. The Government of NCT of Delhi has decided that henceforth, the construction and maintenance of all the Bus Queue Shelters (BQSS) in National Capital Territory of Delhi shall be carried out by Delhi Transport Infrastructure Development Corporation Limited (DTIDCL).
2. 157 BQSS constructed by DTC out of the Government funds would henceforth stands transferred to DTIDCL along with the right of realization of revenue share from the concessionaire M/s Prabhatham Advertising Private Limited.
3. The DTIDCL will sign a supplementary concession agreement with M/s Rajdeep Publicity Private Limited, DIMTS and M/s Prabhatham Advertising Private Limited for execution of the obligations of Transport Department and Delhi Transport Corporation and realization of monthly payment thereof in respect of concession agreements signed by Transport Department and DTC with aforesaid concessionaires for marketing, operation and maintenance of 431 BQSS, 250 BQSS and 157 BQSS respectively.
4. Payment to Municipal Corporation of Delhi ("MCD") shall be made by DTIDCL. However, advertisement tax payable to MCD shall be paid separately by the Concessionaires to MCD and proof of such payment made to MCD shall be deposited with DTIDCL.
5. In future all the BQSS would be constructed by DTIDCL in consultation with DTC and shall also be maintained by the DTIDCL.

6. All the pending receipts of general public in relation to construction, maintenance and shifting of BQSS shall be transferred to DTIDCL by Transport Department and DTC. All the Communications, Parliament/Vidhan Sabha Questions, RTI matters, Public Grievance Commission matters and Court Cases relating to construction and maintenance of BQSS shall be directly dealt by DTIDCL.

7. This has the approval of Hon'ble Minister (Transport), Government of NCT of Delhi.
