ORDER

Cancellation of Offer of Appointment to the post of PGT (English) Female

Whereas, **MS. NEHA SHARMA, D.O.B. 14/04/1991, Roll No. 1960015718** has been nominated by the DSSSB for the post of PGT (English) Female against Post Code 109/17 vide letter No.F1(396)/DSSSB/P&P/2017/964 dated 06/12/2018 vide Result Notice No. 293 dated 01/10/2018 and accordingly an Offer of Appointment was issued to her vide this Directorate Memorandum dated 08/05/2019, the second opportunity was given to her vide public Notice dated 31-10-2019 published in the leading newspapers and Memorandum of Final Opportunity dated 19-11-2019.

1. And Whereas, **MS. NEHA SHARMA** did not report in person on the scheduled date and time as given in the offer of appointment issued to her vide letter of even no. dated 08-05-2019, Public Notice dated 31-10-2019 and Final Reminder of even no. dated 19-11-2019 and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.
2. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment".

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the memorandums dated 08/05/2019, public notice dated 31-10-2019 and 19-11-2019 the candidature in respect of **MS. NEHA SHARMA** is hereby cancelled and the dossier returned to the DSSSB.
