**ORDER**

**Cancellation of Offer of Appointment to the post of PGT (ECO) Male**  
**Post Code 106/17**

Whereas, **Mr. HARJEET SINGH**, D.O.B. 16-08-1988, Roll No. 1950001393 has been nominated by the DSSSB for the post of PGT (ECO) Male against Post Code 106/17 vide letter No.F1(399)/P&P/ DSSSB/2017/2837 dated 24-09-2019 vide Result Notice No. 488 dated 02-08-2019 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum dated 20-11-2019, the second opportunity was given to him dated 05-12-2019 Memorandum of Final Opportunity dated 03-01-2020.

1. And Whereas, **Mr. HARJEET SINGH** did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated 20-11-2019, dated 05-12-2019 and Final Reminder of even no. dated 03-01-2020 and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.
2. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment".

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the memorandums dated 20-11-2019, dated 05-12-2019 and 03-01-2020 the candidature in respect of **Mr. HARJEET SINGH** is hereby cancelled and the dossier returned to the DSSSB.
