ORDER

Cancellation of Candidature for the post of Drawing Teacher-91/17

Whereas, Sh. Manish Kumar Gond DOB 15.07.1993, Roll No. 110509100163 has been nominated by the DSSSB vide letter No. F.1 (390)/DSSSB/P&P/2017/2370 dated 12.06.2019 for appointment to the post of Drawing Teacher (Post Code -91/17) in Directorate of Education, Govt. of NCT of Delhi.

And whereas, after getting document verification an online communication received from the candidate stating that he is not interested to get conduct his medical examination for the post of Drawing Teacher under Post Code-91/17 as the candidate selected anywhere else.

And whereas, memorandum vide no. 2293 dated 23.12.2019 & 2321 dated 31.12.2019 has been issued to the candidate to submit his consent in written or any other mean of communication and surrender the offer of appointment issued vide no. 6673 dated 12.07.2019 within 05 days vide letter no. 2321 dated 31.12.2019, failing which it will be presumed that the candidate is not interested in the said post and claim for the said post will be rejected forthwith but the candidate has not responded.

Therefore, in view of the facts and circumstances as stated above and since the candidate has willfully chosen not to respond to the memorandums, this tantamount to refusal to accept offer of appointment. Therefore, the candidature in respect of Sh. Manish Kumar Gond DOB 15.07.1993, Roll No. 110509100163 is hereby cancelled and the dossier returned to the DSSSB.

Cancellation of Candidature for the post of Drawing Teacher-91/17

Whereas, Sh. Sagar Soyal DOB 24.08.1995, Roll No. 110809100187 has been nominated by the DSSSB vide letter No. F.1 (390)/DSSSB/P&P/2017/2370 dated 12.06.2019 for appointment to the post of Drawing Teacher (Post Code -90/17) in Directorate of Education, Govt. of NCT of Delhi. During the course of scrutiny of the candidate's dossier, it has been observed that the candidate has possessed Master of Visual Art in 10.08.2018, which is after the cutoff date i.e. 31.01.2018 of advertisement No. 04/17 dated 20.12.2017.

Whereas it is clearly mentioned in the advertisement No. 04/17 dated 20.12.2017 that "The educational qualification, age, experience etc. as stipulated in advertisement shall be determined as on the closing date of submission of application ". Therefore the Competent Authority has cancelled the candidature of Sh. Sagar Soyal DOB 24.08.1995, Roll No. 110809100187, as the candidate does not fulfill the eligibility criteria as preset in said advertisement.
