ORDER

Cancellation of Offer of Appointment/Appointment order to the post of PGT
(Home Science)(Post code-188/14)

Whereas, Ms. Shikha Chaudhary, (DOB 05/02/1988) (Roll No.23000862) had been nominated by DSSSB for post PGT (Home Science) against Post Code 188/14 vide letter No. F.1(183)/DSSSB/P&P/13/1105 dated 22/01/2019. Accordingly an offer of appointment was issued to her vide this office memorandum dated 03/07/2019 for accepting the offer of appointment on the terms and conditions stipulated in the above said memorandum and advised to appear in person 26/07/2019. The candidate was present on 26/07/2019 for initial verification of documents.

2. Upon acceptance of the terms and conditions stipulated in the offer of appointment, Ms. Shikha Chaudhary, (DOB 05/02/1988) (Roll No.23000862) had been appointed/posted vide order of even no. dated 06/11/2019 and been given employee Id 20197073 and posted in Pooth Kalan SKV, School Id- 1412027 with the direction to join latest by 05/12/2019 and candidate had not been joined the said post.

3. Now the candidate has represented through email having Dy. No. 832/E-II dated 18/06/2020 and informed/stated that " As I have already joined as PGT (Home Science) in SKV Rithala School Id-1413026 school allotted to me against the post code 93/17 and I do not intend to join in SKV Pooth kalan School ID- 1412027 allotted to me against post code 188/14 therefore, I request you to kindly omit my name from the selection list of post code 188/14 and oblige me". Since, it appear that the candidate is not interested to join against the post of PGT (Home Science) in post code 188/14.

4. As per DoPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of six months from the date of issue of the original offer of an appointment. An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment."

5. Therefore, in view of paras. 1-3 and DoPT OM in para.4 above and with the prior of approval of Director, DoE, the memorandum dated 03/07/2019 and appointment/posting order dated 06/11/2019 interalia candidature in respect of Ms. Shikha Chaudhary, (DOB 05/02/1988) (Roll No.23000862) is hereby cancelled and and the dossier returned to DSSSB.
