**CANCELLATION OF OFFER OF APPOINTMENT AND CANDIDATURE TO THE
POST OF TGT (SOCIAL SCIENCE) FEMALE UNDER POST CODE - 138/17**

Whereas, Ms. Archana Dhaka (DOB 08.03.1992) D/o Sh. Devendra Singh Roll No. 120213801048 has been nominated by the DSSSB vide letter No. F.1 (389)/DSSSB/P&P/2013/2657 dated 16.08.2019 vide result notice 446 dated 27.05.2019 for appointment to the post of TGT (Social Science)-Female under Post Code - 138/17 in Directorate of Education, Govt. of NCT of Delhi.
