Consequent upon selection through Delhi Subordinate Services Selection Board to the post of Drawing Teacher and with the Prior approval of the Competent Authority, the following candidates are hereby appointed purely on Temporary and provisional basis to the post of Drawing Teacher vide post code 208/14 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Candidate has been medically examined by the Dr. N.C. Joshi and declared FIT vide their individual report placed in their respective dossier. In the case of candidates who are referred to Govt. Hospital for medical examination and their medical fitness certificate is awaited (SI.No.5 & 15) the Provisional Appointment is hereby given in relaxation of FR 10 and drawl of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him of the findings of the medical officer/board. In case of OBC candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me are true and correct and the OBC certificate is as per provisions contained in DSSSB advertisement number 208/14 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules". Subsequently, the OBC verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate is hereby directed to report to their respective place of posting latest by 05.09.2020, failing which his/her appointment shall stand cancelled without any further communication.
