MEMORANDUM

In pursuance of receipt of dossier from DSSSB vide letter No.F.1(244)/DSSSB/P&P/2014/1300-1302 dated 05/12/2017 for appointment to the post of Physical Education Teacher (Post Code 210/14) in Directorate of Education, Govt. of NCT of Delhi, this office had issued an offer of appointment to Mr. **Dharmendra Kumar Singh** (Roll No.12608346) vide memorandum No. DE.4/E-IV/Rect.PET/(P.Code-210/14)/2017/205 dated **03.01.2018** with the directions to report to E-IV branch, Directorate of Education, on **16.01.2018** for verification of requisite educational qualification testimonials to check eligibility in accordance with the RRs.

Further, after acceptance of offer of appointment by the candidate, a letter was issued to his residential address "A-48, Phase-I, Mayapuri Industrial Area, Near SK Banquet Hall Delhi-110064" with the direction to report Medical Superintendent, Sanjay Gandhi Memorial Hospital, S-Block, Mangolpuri, Delhi-110083 for medical examination vide letter No. DE.4/E-IV/Rect. PET(P.Code-210/14)/2017/2972 dated 04/04/2018.

Whereas, Medical Superintendent, Sanjay Gandhi Memorial Hospital after examining **Mr. Dharmendra Kumar Singh** (Roll No. 12608346) declared **Temporary Unfit** vide their letter dated 22.10.2018.

And whereas, **Mr. Dharmendra Kumar Singh** (Roll No. 12608346) requested for re-medical vide his application dated 01.02.2019. And on his request a letter was issued to the Medical Superintendent, Sanjay Gandhi Memorial Hospital vide letter dated 14.02.2019 for re-medical examination.

And whereas, since no report received from the Medical Superintendent, Sanjay Gandhi Memorial Hospital, a status report was sought from the hospital vide letter dated 27.06.2019. A memorandum was also issued to the candidate Mr. Dharmendra Kumar Singh (Roll No. 12608346) with the direction to report in E-IV branch of directorate of Education, Delhi and submit the status of medical examination on or before 08.07.2019 failing which it will be presumed that the candidate is not interested in the post and the offer of appointment issued to him will be withdrawn without any further communication. But this office does not received any response.

And whereas, Mr. Dharmendra Kumar Singh was given another opportunity vide letter dated 26.08.2019 to his residential address as well as on his e.mail id hanumandhar@gmail.com with the direction to report this branch with status of medical examination on or before 30.08.2019 giving final opportunity.
