Cancellation of offer of Appointment and candidature to the post of TGT NATURAL SCIENCE (MALE) POST Code 135/17

Whereas, **Sh. MAHESH CHAND**, Roll No. 120113502093 has been nominated by the DSSSB for appointment to the post of **TGT NATURAL SCIENCE (MALE)** against Post Code 135/17 vide Result Notice No. 533 dated 09.10.2019 in the Directorate of Education, Govt. of NCT of Delhi and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum dated 28.11.2019, the second opportunity was given to him vide Memorandum dated 12.12.2019 & final Opportunity vide Memorandum dated 07.01.2020.

- And Whereas, **Sh. MAHESH CHAND** did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated 28.11.2019, second reminder on 12.12.2019 and final reminder of even no. dated 07.01.2020 and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.
- As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the above mentioned memorandums, this tantamount to refusal to accept offer of appointment. Therefore, the candidature of **Sh. MAHESH CHAND** is hereby cancelled and the dossier is returned to the DSSSB.

Whereas, **Sh. ASHISH KAUSHIK, D.O.B. 21-06-1991 , Roll No. 120213500297** has been nominated by the DSSSB for appointment to the post of **TGT NATURAL SCIENCE (MALE)** against Post Code **135/17** vide Result Notice No. 455 dated 28-05-2019 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, it is found that the said candidate has not joined their allotted school till date and moreover no extension request has been received so far in this office.
