Whereas, **SUNDER SINGH**, D.O.B. 12.12.1977, Roll No. 2080000708 has been nominated by the DSSSB for the post of PGT (English-Male) against Post Code 108/17 vide letter No.F.1(396)/DSSSB/P&P/2017/2036 dated 08.03.2019 vide Result Notice No. 315 dated-14.12.2019 and accordingly an Offer of Appointments was issued to him vide this Directorate Memorandum dated 07.06.2019.

2. And whereas, **SUNDER SINGH** appear for verification of documents to the post of PGT (English) Male on 17.06.2019. Deficiency Memo has been issued on 17.06.2019.
