The candidate/candidates is/are hereby directed to join on his/her/their post/posts at respective place of posting latest by 26.10.2020 failing which the appointment order shall stand cancelled without any further communication/notice in this behalf.

The process of verification of character and antecedents to be accomplished within a period of 6 months in accordance with directions issued vide DOPT OM No. 18011/2(s)/2016-Estt.(B)(i) dated 20/06/2016. (ii) Authentication regarding veracity of all documents/testimonials of requisite qualifications inclusive of Caste, Handicap certificate etc for appointment, is to be done by the HOS concerned on joining of the teacher. (iii) In case of OBC candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "the information furnished by the candidate is true and correct and the OBC certificate is as per provisions contained in DSSSB advertisement number 163/7 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature/ appointment is liable to be cancelled/ terminated automatically without any notice and action can be taken against me by the department as per Rules". Subsequently, the OBC verification report will be checked by the DDE concerned.
