OFFICE ORDER

Ms Asha was nominated by DSSSB vide letter No F.1(70)/DSSSB/P&P/2057/Vol.II/3173 dated 27.01.2020 for the post of TGT(Social Science), post code 10/10 Roll No.6011443 under SC category. Accordingly, an offer of appointment was issued to her vide memo No DE.3(98)E-III/DR/2016/1630 dated 04.06.2020 with the direction to appear in person in this office on 18.06.2020 for verification of her educational qualification certificates and other documents. But the offer of appointment returned undelivered by the postal authority with the remarks that "kaphi talashne per prapat karta ka kuchh pata hahi chala atah shi pata vah near mark ya phone no bhi likha kijiye"

A copy of the offer of appointment was also sent to the candidate vide this office memorandum No. DE.3(98)/E-III/DR/2016/2552 dated 30/07/2020 with the direction to appear in person in this office on 12/08/2020, on the address which was different from that of the initial mailing address. The second letter has also been returned undelivered by the postal authority with the remarks that "kaphi talashne per prapat karta ka kuchh pata nahi chala"

Further a final opportunity was given vide memorandum No.F.DE.3(98)/E-III/DR/2016/2880 dated 02/09/2020 directing to appear in this office on 16/09/2020 alongwith all documents for verification. But the said memorandum has also been returned undelivered by the postal authority with the remarks that "Kaphi talashne per kuchh pata nahi chala".

Therefore, the candidature of Ms Asha (Roll No. 6011443) for the post of TGT(Social Science) under post code 10/10 is hereby cancelled and offer of appointment dated 04/06/2020 is hereby withdrawn.

This issues with the prior approval of Competent Authority.




