The Appointment is hereby given in relaxation of FR 10 and drawl of pay and allowances for a period not exceeding 02 months is subject to medical examination within 02 months from the date of Provisional Appointment and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expire of the period of 01 month from the date of communication to him/her of the findings of the medical officer/board. The candidate/candidates is/are hereby directed to join on his/her post at respective place of posting latest by 09.11.2020 failing which the appointment order shall stand cancelled without any further communication/notice in this behalf.

Further, the appointment is subject to: (i) Verification of character and antecedents to be conducted by the office of DDE (District) concerned. In case the character and antecedents are not verified by the relevant agency of the Government or any self declaration tendered by the candidate/ candidates is found to be incorrect/false at any time, the appointment is liable to be cancelled forthwith with initiation of other criminal/legal action as a consequence thereof against the candidate as per law. The process of verification of character and antecedents to be accomplished within a period of 6 months in accordance with directions issued vide DOPT OM No. 18011/2(s)/2016-Estt.(B)(i) dated 20/06/2016. (ii) Authentication regarding veracity of all documents/testimonials of requisite qualifications inclusive of Caste, Handicap certificate etc for appointment, is to be done by the HOS concerned on joining of the teacher. (iii) In case of OBC candidate the appointment will be provisional at the time of joining. The candidate will have to submit an undertaking to concerned Head of the School/office that the information furnished by the candidate is true and correct and the OBC certificate is as per provisions contained in DSSSB advertisement number 208/14 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, the candidature/ appointment is liable to be cancelled/ terminated automatically without any notice and action can be taken against him/her by the department as per Rules. Subsequently, the OBC verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect.
