**ORDER**

**CANCELLATION OF OFFER OF APPOINTMENT AND CANDIDATURE TO THE  
POST OF TGT (SOCIAL SCIENCE) FEMALE UNDER POST CODE - 138/17**

Whereas, Ms. Deepti Rana (DOB 01.07.1989) D/o Sh. Suresh Chander Rana Roll No. 120213801171 has been nominated by the DSSSB vide letter No. F.1 (389)/DSSSB/P&P/2013/2657 dated 16.08.2019 vide result notice 446 dated 27.05.2019 for appointment to the post of TGT (Social Science)-Female under Post Code - 138/17 in Directorate of Education, Govt. of NCT of Delhi. During the course of Document Verification, it has been found that the candidate has not submitted her CTET Certificate and Departmental NOC from her present employer. In this regard a deficiency memo was issued to her on dated 31.10.2019.

Whereas, Ms. Deepti Rana failed to submit her CTET Certificate and Departmental NOC from her present employer for clearing her deficiency memo till date. A reminder dated 18.06.2020 and final reminder of deficiency memo was issued on 23.07.2020.

Therefore, the Competent Authority has cancelled the offer of appointment (provisional and temporary basis) bearing F. No. DE. 3(14)/ DRC/ E-III/ TGT(S.Sc.)/ Female/ 2019/ 2064 dated 27.09.2019 in r/o Ms. Deepti Rana (DOB 01.07.1989) D/o Sh. Suresh Chander Rana Roll No. 120213801171 and the dossier returned to the DSSSB.

**ORDER**

**Cancellation of offer of Appointment and candidature to the post of TGT SOCIAL SCIENCE**  
**(FEMALE) POST Code 138/17**

Whereas, Ms. ASHA, D.O.B. 25/11/1985, Roll No. 120213801168 has been nominated by the DSSSB for appointment to the post of TGT SOCIAL SCIENCE (FEMALE) against Post Code 138/17 vide Result Notice No. 446 dated 27.05.2019 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas, it is found that the said candidate has not joined their allotted school till date and moreover no extension request has been received so far in this office.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

" An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extention of time, It may be considered by the ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is presumed that the said candidate is no longer interested in joining the above mentioned post and hence the competent authority has cancelled the order of appointment and candidature bearing No. DE.3 (14) / DRC (E-III) / TGT (Social Science) /Female/2019/ 638 dated 20/11/2019 with posting ID: 201900344 issued to Ms. ASHA, D.O.B. 25/11/1985, Roll No. 120213801168.
