

Whereas, **Ms. Poonam Chaudhary**, D.O.B. 23/06/1980, Roll No. 2340000779 has been nominated by the DSSSB for the post of **PGT (PET) Female** under the Post Code **95/17** vide Supplementary Result Notice No. 537 dated 31/10/2019 bearing endorsement number No.F1 (417)/DSSSB/P&P/2017/3153 dated 03/12/2019 under sub category "**Departmental Candidate**".

2. And whereas, on scrutiny of the documents available in her dossier from the DSSSB, it is found that **Ms. Poonam Chaudhary** is **OVERAGE** being her date of birth 23/06/1980, as the Sub Category Departmental Candidate is not applicable upon her as she was a Contractual Lecturer in SCERT at the time of filing the application for the post of PGT (PET) Female. She does not qualify the conditions of Departmental Candidate for grant of age relaxation as prescribed by the DSSSB in the Recruitment Notice/Advertisement – 04/17 dated 20/12/2017 which states as under:

"Guest/Contractual Teachers:- Relaxation in upper age as a onetime measure upto the actual time spent as Guest/contract teacher in Dte. of Education subject to a Maximum of 5 years provided that they have worked for atleast 120 working days in the particular year this would be applicable to those guest/contract teachers who have worked for academic year 2012-13,2013-14,2014-15,2015-16 & 2016-17)".

3. Therefore, In view of para 2 and non-fulfilling the condition of being the Departmental Candidate in terms of the Recruitment Notice/Advertisement – 04/17 dated 20/12/2017, the candidature of **Ms. Poonam Chaudhary** D.O.B. 23/06/1980, Roll No. 2340000779 is hereby stand cancelled and her dossier is being returned to the DSSSB.
