
And, whereas, after successful verification of documents, Sh./KM CHANCHAL appointed to the post of Assistant Teacher(Nursery) under post code-88/17 vide appointment Order No.DE.4(2)/DRC/E-IV/PRT/2019 dated 16.10.2019, posting ID 20190181 dated 15.10.2019.

And, whereas, Sh./KM CHANCHAL not joined to the post till 15.12.2019 and also after issuing final opportunity vide F. No. DE.4(13)/DRC/E-IV/Misc. Not Join/2019/7016 dated 03.09.2020 with the direction to join within 10 days from the date of receiving of this memorandum in the school allotted, but the candidate has neither join their duties nor requested for seeking extension for joining to the post, which shows that he/she is unwilling to join the post of Assistant Teacher (Nursery) under post code 88/17.
