ORDER

Cancellation of Candidature for the post of Physical Education Teacher -90/17

Sh./Ms. AJAY KUMAR, DOB 06/12/1994, Roll No.2700012264 has been nominated by DSSSB for the post of Physical Education Teacher under post code-90/17 and accordingly an offer of Appointment was issued to him/her.


And, whereas after successful verification of documents, Sh./MS. AJAY KUMAR appointed to the post of Physical Education Teacher-90/17 vide appointment Order No.DE.4(7)/DRC/E-IV/PET/2019/1005 dated 16.10.2019 posting ID 20190182 dated 16.10.2019.

And, whereas Sh./MS. AJAY has not joined the post till 21.02.2020 also after issuing final opportunity vide F. No. DE.4(13)/DRC/E-IV/Misc. Not Join/2019/7031 dated 03.09.2020 with the direction to join their duties within 10 days from receiving of this Memorandum, in school allotted but the candidate has neither join their duties nor requested for seeking extension for joining the post, which shows that he/she is unwilling to join the post of Physical Education Teacher under post code 90/17.

Therefore, in view of the above facts and circumstances and since the candidate has willfully chosen neither joining the school allotted to him nor requesting for any extension for period of joining the post, the provisional appointment order issued to Sh./MS AJAY KUMAR vide Posting ID 20190182 and the candidature is hereby stand cancelled and the dossier of the candidate returned to DSSSB for further necessary action at their end.
