ORDER

This department is in receipt of many representations from the Guest Teachers regarding correction in their working days. In this regard, Guest Teachers are directed to go to the link **Edudel.nic.in----Login----Guest Teachers login**, to check their number of working days (year wise).

Further, in case of any objections in r/o number of working days of any Guest teacher (including the Guest teachers who are currently relieved), the concerned Guest Teacher may contact the DDE concerned, within 05 working days, who shall rectify the anomalies in the data, if any, noticed in such cases and take all such actions as deemed fit i.e. deletion of experience certificate etc. to ensure the correctness of the data so preserved on the online module. Thereafter, the concerned HoS may issue fresh experience certificate to the concerned Guest Teacher after verifying the data in respect of number of working days. The whole exercise is to be completed by the concerned DDE till 09.12.2020 positively, after that it will be presumed that there is no objection/anomaly in the data in r/o working days of Guest teachers. Thereafter, no request for change in number of working days shall be entertained by the Department.

Further, many representations have also been received from the Guest teachers who have been relieved due to various reasons such as promotion, direct recruitment, PFC etc., regarding their re-engagement to any other school. In this regard an option button has been given at the link below, through which the relieved Guest Teacher(Except Non CTET), whose ID is still active may give his/her willingness to work with the department:



The ID of the login will be same as the employee ID of the Guest Teacher and password will be their Tab password or date of birth of the concerned Guest Teacher, for example if date of birth of any candidate is 29th August 1981, then his/her password shall be 29081981. Further, the Guest teacher concerned may also change his email ID, contact number and address through above given link. However, if any Guest teacher failed to click the willingness option by 09.12.2020, it will be presumed



that he is no longer interested in working with the department as a Guest Teacher and his/her ID will be disabled. It is also to mention that chance of re-deployment will be given to only those Guest Teachers who shows his willingness to work with the department through the above given link. This will not apply in case of a Guest teacher who has been disengaged due to misconduct, misbehavior, remained on leave without permission of HOS, poor performance or resigned due to personal reasons.

This issues with the prior approval of the Competent Authority




