**Cancellation of Offer of Appointment to the post of PGT (Pol.Science) Male Post Code 114/17**

**Sh. Satish Kumar**, D.O.B. 01.07.1989, Roll No. 2370000144 has been nominated by the DSSSB for the post of **PGT (Political Science) Male** against Post Code **114/17** vide letter No.F1 (413)/DSSSB/P&P/2017/3066 dated 08.11.2019 vide Result Notice No. 417 dated 30/04/2019 and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum dated 06/12/2019.

And whereas, after successful verification of documents, **Sh. Satish Kumar** appointed to the post of PGT (Political Science) Male vide appointment Order No.DE-2(26)/DRC(E-II)/PGT(Political Science)/Male/2019/4067 dated 23/01/2020 posting ID 20200023. Whereas, **Sh. Satish Kumar** neither joined the post till 14.12.2020 in school allotted to him even after lapse of more 10 months nor requested for any extension for joining the post, which shows that he is unwilling to join the post of PGT (Political Science) Male.
