Deployment Order

In Continuation of earlier Deployment Order issued vide F. No. R.127/Enf/F&S/2019/55-63 dated 27.01.2020 for Feb, 2020 and in accordance with Clause 7 (6) and (7) of the Targeted Public Distribution System (Control) Order, 2015 the above Clause and in compliance of Order No.F.15(380)/CFS(D)/Misc./2016/Pt.file/377-87 dated 04.09.2019 issued by the Asstt Commissioner (D) [copy attached], deployment as per **Annexure-I** is hereby ordered with immediate effect for the months of **March, 2020**.


The officials concerned shall be required to:

1. Inspect, along with the officials of FCI and DSCSC, the stocks of food grains intended for issue to the fair price shops to ensure that the stocks conform to the prescribed quality specifications. The para-meters for checking of food grains by the FCI laboratory are foreign matters, broken, damaged/slightly damaged, sprouted, shriveled, weevilled, argoty and karnal bunt;
2. Ensure that after the joint inspection, the FCI issues sealed samples of food grains for display at the fair price shops;
3. Submit regular reports including discrepancies noticed, if any, soon after such inspections to the Asstt Commissioner [Distn], along with a copy to the Asstt Commissioner [Enf].

The inspection duty shall be in addition to the regular duties of the officers in the respective circle offices.

In case the concerned officer is on leave the duty shall be performed by the link Officer.
