Your department has notified following three services of Irrigation Flood Control Department with e-SLA services/portal vide notification dated 13.12.2012 which are as under:

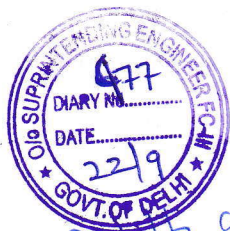
