<u>ORDER</u>

Whereas, Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization.

And, whereas, all retail vends and warehouses were shut down vide order dated 23.03.2020 till 31.03.2020 in pursuance of the instructions issued by the Health and Family Welfare Department, GNCTD of Delhi to contain the further spread of Corona Virus which was further extended till 31.05.2020 in view of national wide-lockdown.

And, whereas, with reference to the Order No. 40-3/2020-DM-(I(A) dated 30.05.2020 of the Ministry of Home Affairs, Government of India, the Delhi Disaster Management Authority (DDMA) has issued guidelines regarding permissible & non-permissible activities in Delhi vide Order No. F/02/07/2020/S.I/Part File/212 dated 01.06.2020 wherein activities in regard to all shopping malls were prohibited throughout the NCT of Delhi.

And, whereas, Delhi Disaster Management Authority (DDMA) in continuation to its previous Order dated 01,06.2020 has issued fresh directions vide its Order dated 07.06.2020, wherein it has now been directed that the following activities, which were hitherto prohibited/partially prohibited/restricted shall now be permitted throughout the NCT of Delhi w.e.f. 08.06.20 except in containment zones, subject to compliance with Standard Operating Procedure(SOP) issued by the Ministry of Health & Family Welfare, Govt. of India vide Office Memorandum dated 04.06.2020:

- (i) Restaurants
- (ii) Shopping Malls,
- (iii) Religious places/places of worship for public.

However, Ministry of Home Affairs, Govt. of India vide its aforesaid order dated 30.05.2020, duly endorsed by DDMA vide its order dated 01.06.2020, has issued Guidelines for Phased Reopening (Unlock 1) of activities wherein, inter alia, it has been categorically stated that the dates for re-starting the bars will be decided in Phase-III only.

Accordingly, now, with the approval of Competent Authority, the following directions are hereby issued:

- 1. All bar licenses in Hotels, Clubs and Restaurants granted in the form of L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F, L-19/L-19F, L-20/L-20F, L-28/L-28F and L-29/L-29F Licenses shall remain non-operational till further orders.
- 2. All L-10 vends (located in Shopping Malls) are not allowed to open their shops without conducting MSR activity.

- 3. All L-10 licensees(located in Shopping Malls) are directed to conduct MSR activity between 8th June and 9th June, 2020. After completion of MSR activity, the licensees shall submit a compliance report to AC (L-10), Excise Department along with the undertaking that the shop does not fall under the containment zone. Only after submission of the MSR compliance report and the undertaking from the licensee, the shops shall be allowed to be opened subject to strict compliance of National Directives for COVID-19 Management and Standard Operating Procedure (SOP) on preventive measures in shopping malls to contain spread of COVID-19 issued by Ministry of Health and Family Welfare and guidelines issued by DDMA.
- 4. All the L-10 Vends, that may be allowed to operate by the Excise Department, may open on daily basis (except dry days) from 09:00AM to 08:00PM.
- 5. In case, any L-10 vend located in Shopping mall is opened on the basis of any false information, the license of the shop shall be liable to be cancelled.
- 6. In case, any L-10 vend located in Shopping Mall or elsewhere allowed to operate comes under the containment zone in future, the same shall be closed immediately.
