ORDER

Whereas, Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization.

And whereas DDMA after reviewing the situation of COVID-19 in Delhi vide its order No.F.24/DDMA/COVID-19/2020/338 dated 31.10.2020 has decided that status quo in respect of prohibited permitted activities (including activities on trial basis) may be maintained in NCT of Delhi till 30.11.2020 or further orders whichever is earlier.

Accordingly, in continuation to this office order dated 01.10.2020, it is hereby ordered to maintain status quo in respect of the activities related to bars in Hotels/Clubs/Restaurants for 'on' premises consumption of liquor under the licence category L-15/L-15F L-16/L-16F, L-17/L-17F, L-18/L-18F, L-19/L-19F L-20/L-20F L-28/L-28F and L-29/L-29F upto 30.11.2020 or further orders whichever is earlier subject to strict compliance of the conditions issued vide this office order dated 04.09.2020.

It is reiterated that owner of the establishment/heensee of Hotels/clubs/restaurants concerned shall ensure the compliance of SOPs failing which he/she shall be proceeded against as per the provisions of the section 51 to 60 of Disaster Management Act 2005, besides legal action under section 188 of IPC. Further, prosecution shall also be launched against the General Manager/Manager of the premises, and the premises shall be sealed forthwith, Excise licence of the establishment shall also be liable to be cancelled.
