

Whereas, Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization.

And whereas, vide this office order dated 24.09.2020, the amount of second Installment of remaining license fees was allowed to be reduced for the period of lockdown w.e.f. 25.03.2020 to 08.09.2020 (i.e. 07 days of excise year 2019-20 and 161 days of excise year 2020-21).

And whereas, a number of representations were received from the stakeholders who made payment of the licence fee in full, for excise year 2020-21, seeking relief from payment of excise licence fee of the lockdown period.

And whereas, considering the requests of its stakeholders, the competent authority has allowed adjustment of licence fee to be paid for excise year 2021-22, by the licensees holding excise licence in form of L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F, L-19/L-19F, L-28/L-28F and L-29/L-29F as per detailed annexed herewith.
