**ORDER**

This order will dispose-off the appeal filed by Sh. Ravinder Kumar Mirg in respect of RTI I.D. No. 15501.

1. Sh. Ravinder Kumar Mirg, Appellant present on the date of hearing i.e. 04.09.2020.
2. Sh. Vijay Raj, Section Officer for SPIO/DS (EP) present on the date of hearing.
3. Case called. During the hearing the appellante raises technical issue of letter to Ms. Halima Sultana in excess to the mandate of Section 11 by seeking consent while the same is not expressly provided in the statute. He further submits that the delay is huge for 75 days or so. The third party information too has come after the limitation period of 10 days. Appellant also draws attention to see proviso to 11(1) & 19(5) of the RTI Act, 2005. He further states that the reply of Ms. Halima Sultana should not be considered and the details should be revealed to the applicant.

The SPIO (EP) is directed that a revised factual reply to be given to the applicant within 10 days from today.

**In light of the above, this appeal is disposed-off accordingly.**

However, if aggrieved with this decision he may file an appeal before the second Appellate Authority within 90 days of receipt of this order.
