**1. Brief facts of the case.**

1.1 Shri Ateet Kathura has filed a grievance petition in PGC, aggrieved by non receipt of GST refund, the State part. He requested for Commission's intervention to issue directions to the Trade & Taxes Department for release of GST refund early.

**2. Facts emerged during the proceedings.**

2.1 Shri Karmavir Singh, GSTO, Ward-66 representing the respondent department filed an action taken report. The same has been taken on record.

It states that the said payment of Dhoom Creation on account of GST Refund, amounting to Rs.43,809/-, 41,194/- and 84,731/-, had already been processed by Accounts Branch of Trade & Taxes Department, GNCTD vide bill no.53 dated 13.6.2019 as per bank details provided to the Department (Kotak Mahindra Bank, Account No.0211590574, IFSC Code No. KKBK0000215, MICR Code 110485049).

**3. Directions**

3.1 The complainant is advised to contact Shri Karamvir Singh, GSTO, Ward-66, Department of Trade & Taxes, GNCTD in case

payments are not released and received in the bank account. Also, he may check with his bank and update his passbook to ascertain credit of said refund in his account in view of the submissions of the Department.

A copy of the action taken report furnished by GSTO,Ward-66 of the respondent department be also sent to the complainant.

3.2 With the above directions, the case of complainant stands disposed in the Commission.
