1. <u>Brief facts of the complaint</u>

Shri Hari Singh has filed a grievance in this Commission against unauthorized construction at H.No. 2163 Chah Indara Behind Jubilee Cinema, H.C.Sen Road, Delhi – 110006 by Sh. Mahender Kumar and Rajender Kumar.

2. Proceedings in the Public Grievances Commission

3. Relevant facts emerging during the hearing

3.1 Sh. N.K.Gupta, Asstt. Engineer (B), City SP Zone is present in the hearing and submitted a report stating that

"Property No. 2163 Chah Indara Behind Jubilee Cinema, H.C.Sen Road has been sealed at three points at ground floor on 18.12.2019 as per provisions of the DMC Act."

3.2 The complainant's brother Shri Chander Prakash has submitted a representation stating that the complainant has some domestic dispute with his brother (i.e. party complained against)

which has now been sorted out and has requested for withdrawal of his complaint.

3.3 The party complained against needs to apply for regularization of his property to the department after demolishing non compoundable portion of the property.

The party complained against has approached the Commission stating that he will file an application for regularization of the property and requested for de-sealing of the same.

4. Recommendations of the PGC

- 4.1 Sh. N.K.Gupta, Asstt. Engineer (B), City S P Zone is advised to take necessary action in the matter as per provisions of the DMC Act once the application for regularization is filed by the party complained against in the matter.
- 4.2 Ms Veditha Reddy, Deputy Commissioner, City SP Zone is advised to ensure that action in the matter is taken by the concerned officers as per provisions of the DMC Act.

With the above directions the matter stands closed at the level of this Commission.
